Moved that the Country Residential subdivision of SW 28-4-29-W4M (Certificate of Title No. 101 224 720), to create a 10.0 acre (4.05 ha) parcel from a previously unsubdivided quarter section of 159.63 acres (64.7 ha) for country residential use; BE APPROVED subject to the following:

RESERVE:

That, the environmental reserve requirement, pursuant to Sections 661 and 664 of the Municipal Government Act, be provided as a 10m easement along the bank of Marr Lake within the proposed subdivision with the actual acreage to be dedicated being determined at the final stage, for Environmental Reserve purposes.

CONDITIONS:

1. That, pursuant to Section 654(1)(d) of the Municipal Government Act, all outstanding property taxes shall be paid to the M.D. of Pincher Creek No. 9.
2. That, pursuant to Section 655(1)(b) of the Municipal Government Act, the applicant or owner or both enter into a Development Agreement with the M.D. of Pincher Creek No. 9 which shall be registered concurrently with the final plan against the title(s) being created.
3. That the applicant/owner install a septic tank and field or other suitable private sewage disposal treatment system to replace the existing system in accordance with Private Sewage Disposal Systems Regulation and as provided by the Alberta Private Sewage Systems Standard of Practice 2009.
4. That, as requested by Alberta Transportation, a 30m wide service road right of way be registered on title by caveat for the 10 acre country residence prior to finalization of the application.
