The South Canadian Rockies Tourism Advisory Committee (RTAC) is being established as a collaborative platform to strengthen communication and coordination between our region's municipalities—the Municipality of Crowsnest Pass, MD of Pincher Creek, the Town of Pincher Creek, and ID4/Waterton Lakes National Park. ## RTAC will:

- Assist in accessing new streams of funding for municipalities and/or their respective tourism stakeholders;
- Streamline communications with the South Canadian Rockies Tourism Association and all regional tourism stakeholders;
- Share detailed information on investment in SCR's investment and activity in each community;
- Identify collaborative tourism projects and funding application opportunities;
- Streamline and coordinate regional tourism development advocacy narratives.

The committee will meet quarterly (in person where possible) with a clear agenda and minute-keeping for transparency and follow-up, with all meeting coordination, including food and beverage service, coordination, and meeting administration, provided by SCRTA.

Your commitment to participate will help the entire region benefit from a unified, strategic approach to tourism as economic development and ensure access to new and traditional streams of funding.

Please confirm your council's appointees at your earliest convenience so planning for the inaugural meeting may proceed.

# South Canadian Rockies Regional Tourism Advisory Committee (RTAC)

### **Terms of Reference (Draft)**

## 1. Purpose

The South Canadian Rockies Regional Tourism Advisory Committee (RTAC) provides a collaborative platform for municipalities in the South Canadian Rockies to work together on tourism as a driver of economic development.

RTAC brings together council members from the Municipality of Crowsnest Pass, MD of Pincher Creek, Town of Pincher Creek, ID4, and Waterton Lakes National Park. The committee's purpose is to:

- Strengthen communication between municipalities, the South Canadian Rockies Tourism Association (SCRTA), and communities.
- Identify and explore collaborative tourism projects, especially those eligible for joint funding.
- Share information, perspectives, and priorities to align tourism with broader community needs.
- Build trust and transparency between elected officials, administration, and the SCRTA.

RTAC is an advisory body that adds value by bringing partners together. While it does not make operational or governance decisions, and is not responsible for delivering programs or services, its strength lies in:

- Collaboration providing a platform for municipalities and partners to work together on shared priorities.
- Information-sharing ensuring members are informed about tourism trends, opportunities, and community needs.
- Opportunity-building identifying areas where joint advocacy, funding applications, or regional initiatives could benefit multiple communities.

#### 2. Roles & Responsibilities

#### **Council Members**

- Represent their municipality's voice and priorities in regional tourism discussions.
- Act as a bridge between RTAC and their municipal council by sharing updates and perspectives.
- Provide feedback on tourism opportunities, community needs, and infrastructure gaps.
- Support SCRTA's efforts by connecting regional projects with municipal governance.
- Contribute to advocacy and help align tourism initiatives with local planning and budgets.

#### **South Canadian Rockies Tourism Association (SCRTA)**

- Facilitator and Coordinator of RTAC. SCRTA will prepare agendas, circulate meeting materials, take minutes, and provide follow-up.
- Ensure meetings focus on clear purpose and outcomes, avoiding "talk with no action."
- Share factual information, research, and updates to strengthen awareness and overcome anecdotal perceptions.
- Identify funding opportunities and coordinate joint applications where regional collaboration adds value.
- Provide continuity and accountability between meetings.

## **Chief Administrative Officers (CAOs)**

- CAOs may be invited to attend selected meetings or initial sessions to build transparency around staff capacity, budgets, and project feasibility.
- Provide input on realistic opportunities and limitations to ensure discussions remain grounded.

#### 3. Membership

- Minimum 1 (One), maximum of 2 (two) appointed council members.
- Substitutions are not permitted, except by a CAO if a council member is unable to attend.
- In the event a CAO cannot attend, an official staff member working under the "Marketing" or "Communications" department within a municipality may attend, provided reports are sent back to council.
- Council members serve as appointees for one-year terms, renewable at the discretion of their council.

### 4. Meeting Frequency & Format

- Quarterly meetings (four per year), in-person where possible. Virtual attendance will be available if required.
- SCRTA will cancel and reschdule meetings if the majority of members cannot attend.
- Each meeting will include:
  - Circulate the agenda in advance.
  - Documentation of minutes and key outcomes.
  - Clear restatement of RTAC's purpose and priorities to maintain focus.
- SCRTA may call additional meetings if a pressing funding opportunity or advocacy issue arises.

#### 5. Decision-Making

- RTAC does not make binding decisions.
- Where direction is needed, SCRTA will record discussions, and a consensus or majority view will be noted in the minutes.
- Formal decisions (e.g., budget commitments, project approvals) remain the responsibility of individual councils and the SCRTA Board.

#### 6. Focus Areas

RTAC will concentrate on two main areas:

- 1. **Understanding Needs** Identifying tourism-related opportunities and challenges in each community, and exploring how they can be addressed collaboratively.
  - Distinguish between issues that are strictly local vs. those that benefit from a regional approach.
  - Share infrastructure gaps, policy challenges, and advocacy opportunities.
- 2. **Collaborative Funding** Exploring joint funding opportunities where regional collaboration strengthens applications.
  - Work with SCRTA to identify new sources of funding that municipalities could not access alone.
  - Support applications that combine multiple communities, projects, or shared infrastructure.

#### 7. Outcomes & Value

RTAC is intended to deliver clear value to both municipalities and the SCRTA:

#### For Municipalities

- A structured way to bring local priorities into regional tourism planning.
- Access to larger and more competitive funding opportunities.
- Stronger advocacy voice with provincial and federal governments.
- Better alignment between municipal infrastructure planning and tourism growth.

#### For SCRTA

- Direct political support and credibility.
- Access to community-level insights and priorities.
- Stronger partnerships to amplify regional initiatives.
- Greater ability to deliver results and demonstrate value to members and funders.

#### 8. Time Commitment

- Quarterly meetings: 1.5–2 hours each.
- Occasional review of materials in advance of meetings.
- Optional participation in project-specific working groups, if established.

#### 9. Facilitation

SCRTA will provide all administrative support, including:

- Meeting invitations, agendas, and preparation.
- Minute-taking and follow-up.
- Tracking of action items and project updates.
- Ongoing liaison between members and communities.

This ensures council members' time is respected, with a focus on purposeful meetings that lead to visible outcomes.

#### 10. Review of Terms of Reference

- SCRTA and the Committee will review these Terms of Reference annually to ensure they remain relevant, practical, and aligned with regional priorities.
- SCRTA or any member municipality may propose updates, and they must be agreed upon by majority consensus at RTAC.
