a) Pincher Creek Community Hall Board

Mike Killoran with the Pincher Creek Community Hall board attended the meeting at this time requesting to know why the Community Hall was denied funding through Joint Funding. In their application they requested \$30,000 towards installation of a new door, furnace repairs and utility costs. At present time the rentals are not covering the utility expenses, and the hall is struggling. They have been in touch with the grant writer, but finding grants for utilities is very difficult and they are not allowed to use casino funds for it.

# b) Pincher Creek Early Learning Centre

Christy Gustavison and Michelle Spencer, members of the board, and Director Ola Crook, for the Pincher Creek Early Learning Centre, attended the meeting to discuss with Councils the history of the centres and financial struggles they are facing.

Sage centre opened this week, after being shut down in October due to lack of qualified staff. Currently they are recruiting, and can't be at capacity for childcare until they have the correct staffing. Also, the Province has frozen fees, so they aren't able to raise fees to cover the cost of running the centers.

The board members encouraged a representative from the MD to join the board.
